FIRST AID MEASURES

STABILITY AND REACTIVITY

The product is stable under recommended conditions of storage and use.

TOXICOLOGICAL INFORMATION

Continuous exposure for professional reasons to detergents (soap, shampoo, liquid detergents) can lead to depletion of the hydrolipidic mantle and the stratum corneum, which are the natural skin barrier.
