- Eco-dermo compatible products contain the latest generation molecules. These reduce, to lowest levels, the outburst of allergic dermatological or respiratory allergies through contact or inhaling.
- These products do not contain any scents which reduces to mini mum levels the risk of allergies.
- Dosers releasing larger drops compared to the last generation ones.
  The larger drop system has been designed to create less aerosol.
- By using a spray that filters incoming air, atmospheric bacteria is prevented from entering the container and polluting its content.
- The use of matt containers prevents bacteria from building, in particular algae.

### Safety

Safety is a precious resource if supported by reliable and faultless tests. For this reason, we had Operational Units and Departments of a prestigious Italian University carry out clinical experiments.

- We chose the University of Bologna, which allowed us to unite under one single ethical committee and the following Operating Units:
- DERMATOLOGY DEPARTMENT of the Polyclinic Hospital S.Orsola Malpighi, which carried out hypoallergenicity and safety tests under a dermatological profile.
- OCCUPATIONAL MEDICINE DEPARTMENT Polyclinic Hospital S. Orsola Malpighi for the tests of respiratory provocation able to show that this product does not cause bronchial irritation (at the tested concentrations). All these department units centre around the Department of Internal Medicine, of Aging and Nephrological Deseases – University of Bologna.
  - Mister Dry Zero Voc products have been declared clinically hypoal-lergenic under the dermatological and respiratory profile. With the aim of creating a product with the highest safety levels, we have tested it on people suffering from MCS (Multiple Chemical Sensitivity). When we took part in the conference by A.M.I.C.A., we were able to draw some results based on Italian patients and the scientific community, which studies these disorders. From the study carried out, the following outcome could be drawn:
- According to the international association Global Initiative for Asthma, 300 million people in the world suffer from this disease, that equates to 1 in 20 people.
- In Italy, it is estimated that approximately 9 million people every year get ill with respiratory diseases and 4 million seek medical help. It has been calculated that approximately 15-20 per cent of the Italian population suffer from 'generic' allergies, which is a growing phenomenon mainly amongst youngsters and women.
